United Way of Franklin County Community Campaign Raffle!

ELIGIBILITY AND RULES

1. This raffle is governed by and shall be run consistently with the Pennsylvania Small Games of Chance Act, December 10, 1988 and subsequent amendments. Any representations in violation thereof are strictly forbidden.
2. Individuals making a donation pledge of at least \$182 per year to United Way of Franklin County for the 2026 campaign and who is not ineligible under the Act or these rules will be eligible.
3. Donations to United way of Franklin County Community Impact Fund or Focus Area are eligible for the raffle. Donations designated to a United Way of Franklin County event or an agency other than United Way of Franklin County are not eligible.
4. Donors who contribute at least \$182 annually are automatically entered once into the raffle prize drawing.
5. Donors who contribute at least \$364 annually are automatically entered twice into the raffle prize drawing.
6. To be eligible for entry, pledges must be received by United Way of Franklin County between August 24, 2026 through December 31, 2026.
7. Names will be drawn at United Way of Franklin County office located at 182 S. Second Street, Chambersburg, PA 17201 on Friday, January 15, 2027 at 11am EST and United Way of Franklin County will call winners utilizing contact information provided at time of pledge. Winners will be announced at our Annual Meeting in late January 2027. Winners must respond within 30 days of the annual meeting to claim their prize, or the prize is forfeited. The prizes are as follows:
 - a. First Prize: \$2,000 cash prize.
 - b. Second Prize: \$1,000 cash prize.
 - c. Third Prize: \$500 cash prize.
 - d. Fourth Prize: \$500 cash prize.
8. Members of the staff and the Board of Directors of United Way of Franklin County and their immediate families are not eligible. Immediate family includes spouse, parents and children.
9. The winners are required to provide proper photo identification and verification upon presentation of the prizes.
10. The winners, by entering their name, agree that United Way of Franklin County may use their name and/or photographs for publicity purposes upon acceptance of the prizes.
11. The winners will be required to sign a release form and hold harmless agreement in favor of United Way of Franklin County and their respective agents and employees. The information on this agreement will be used to issue a 1099 for income tax purposes.
12. Winners must pay applicable taxes relating to these transactions, including, without being limited to, federal and state income taxes.
13. No cash equivalent will be provided in lieu of receipt of the prizes. Prizes are not transferable.
14. Participation in this raffle may affect the tax deductibility of your gift. You should consult your tax advisor for more detailed information.
